TERMS AND CONDITIONS

1. Membership

1.1 To become a member, a person must complete an Application Form and pay the membership fees as they become due.

1.2 The acceptance of a membership is at the sole discretion of the management and EDITION reserves the right to refuse membership and /or access to the facilities at any time without any explanation or reason.

1.3 All members are issued a membership ID card that holds your details as well as the details of your membership. This card also allows you to avail some of exclusive benefits and savings around our hotel, which are outlined below. All membership cards remain the property of EDITION and should the cards be misused or abused they will be revoked along with all benefits and savings associated. Lost cards will be replaced at the cost of 100AED per card per member. Members are required to show their card in order to gain access to the gym, pool or Spa and so should always carry their card while on property.

2. Termination

2.1 EDITION reserves the right to terminate or suspend membership for breach of the Terms and Conditions, or for misconduct of the member or their guest which is considered damaging to the character or interests of the gym, offensive to other members, guests or staff of EDITION.

2.2 Any member so expelled shall forfeit all privileges to the gym and shall not be entitled to any pro-rata payment of fees for any period during which membership is suspended or terminated.

3. Limitation of Liability

3.1 For security reasons, members and guest are advised to store personal belongings and valuables in lockers, which are provided for their convenience. Use of lockers is at the members own risk.

3.2 It is the responsibility of all members and guests that he/she is in good physical condition and capable of undergoing a routine of exercise whether or not provided by any programme or class attended. Members and guests are advised to consult a doctor prior to beginning any programme, treatment or class. Certain medical conditions may mean you will need a medical referral and /or a specific exercise program.

3.3 Members and guests who are pregnant are advised to consult a doctor prior to engaging or continuing any form of physical activity, undertaking any treatment or facilities.

4. Code of Conduct/ Behaviour

4.1 Members and guests should conduct themselves in a quiet and well-mannered fashion when in or about the facilities and in a manner that will not disturb other members and/or guests. In particular, members and guests should not use foul, loud or abusive language, or molest or harass other guests or members of staff. A single breach in respect to this code of conduct will be sufficient to result in suspension or termination of membership, at EDITION's sole discretion.

4.2 Members are asked to dress appropriately when using the gym and members may be asked to leave the gym if attire is not considered suitable. In accordance with local custom, members and guests are advised to refrain from walking around changing rooms without clothing.

4.3 Members and guests must: (a) not bring pets to any part of EDITION premises; (b) not smoke in any part of EDITION premises; and (c) not bring, use or be under the influence of illegal drugs or substances in any part of the property.

5. Recommend a Friend:

The Recommend a friend bonus applies to all memberships under the following guidelines:

- 5.1 Your recommended friend signs up for one year, you will receive 30 days extension to your membership.
